This supplement no. 1 (the "**Supplement**") is supplemental to, forms part of and must be read and construed in conjunction with, the base prospectus dated 11 June 2019 (the "**Base Prospectus**"), prepared by Kommuninvest i Sverige Aktiebolag (publ) (the "**Issuer**") in connection with its Euro Note Programme (the "**Programme**") for the issuance of notes ("**Notes**") guaranteed by certain regions of Sweden and certain municipalities of Sweden (the "**Guarantors**"). Terms given a defined meaning in the Base Prospectus shall, unless the context otherwise requires, have the same meaning when used in this Supplement.

This Supplement and the Base Prospectus together constitute an alleviated prospectus for the purposes of Chapter 2 of Part III of the Luxembourg law of 16 July 2019 on prospectuses for securities.
